

# YMCA Case Study



## COLLINS COMPUTING FOR YMCA'S

Collins Computing created the **Y-Suite** product in collaboration with the YMCA to combine a series of Payroll enhancements that increase the effectiveness of **Microsoft Dynamics GP** in a single package. Designed specifically for the YMCA, the **Y-Suite** includes the following customizations:

- **403B Eligibility Report** — produces a list of employees who qualify, or are about to qualify, for enrollment in the YMCA Retirement Fund.
- **Payroll Code Matrix** — decreases the manual labor required to enter payroll information by condensing and simplifying the data entry process.
- **YERDI Payroll Interface** — facilitates the calculation of participant contributions to the YMCA Retirement Fund and checks the contribution limits by automating the download of payroll information.
- **Payroll Export** — creates a journal entry and exports a text file after payroll has been processed for the Y-Vision program.
- **Void Payroll Checks** — creates “void checks” general ledger transactions and exports corresponding text file to be used by the Y-Vision program.
- **Retirement (YERDI) Interface** — automatically enrolls newly eligible employees into the YERDI retirement system, and then continually updates the system with relevant payroll information.

It was built on a character based code that didn't support transactions such

as simple credit card charges and online registrations. They couldn't import data into the system and if they needed to export anything, it was all character based and required time-consuming manipulation within Microsoft Excel to get the data in a format that was usable. The data was also stored on various disks that only a remote operator could locate. This made real-time information about their business nearly impossible to obtain.

YMCA of the Foothills tried everything to patch Custos but in the end it took too much time and effort to train people, they couldn't export to Microsoft Excel, and they no longer had trust in the information it provided. They realized it was time to change when they couldn't get the trial balance to reconcile. This was an indication of a much bigger problem. If the trial balance was off, what other discrepancies were there? And how could they trust their data?



## SOLUTION

After researching their options, YMCA of the Foothills decided to implement Daxko to manage all their operations. But they quickly found that the financial management within Daxko as not robust enough for their specific needs so they contacted Collins Computing for help in implementing Microsoft Dynamics® GP. 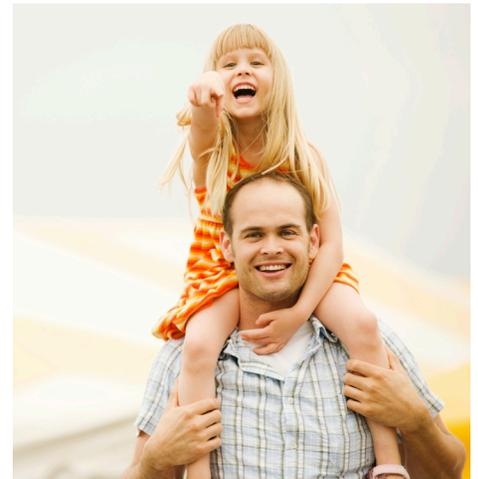
Microsoft Dynamics GP gives YMCA of the Foothills the flexibility to provide valuable information for the success of their mission.
